Pursuant to the provisions of Section 36.00, Chapter 2, Statutes of 2020, the following report is respectfully submitted.

Augmentation to the following non-Budget Act item is needed to provide support to California's small businesses that are experiencing extreme financial hardships due to the COVID-19 pandemic and mitigation efforts being used to reduce the pandemic.

\$50,000,000 to Item 0509-601-0001 for the Small Business Finance Center at the California Infrastructure and Economic Development Bank (IBank) to mitigate barriers to capital for those small businesses that do not qualify for federal disaster funds, including businesses in low-wealth and immigrant communities. The augmentation will be used to recapitalize IBank's Small Business Loan Guarantee Program (SBLGP). The program utilizes Financial Development Corporations and Community Development Financial Institutions to provide loans to small businesses, which are guaranteed by the SBLGP.

Finance concurs with the necessity of these changes to the enacted budget and will be approving these augmentations not sooner than 72 hours from the above date.
